- Assignor is taking a \$2500.00 pay cut by not assigning these schools.

#### - RATING SYSTEM

- Coaches Review will be 60%
- Rate each Official who meets the requirements of the KHSAA to do Post Season.
- Coaches will label Referees with a 1 to 10 Scale and then each point will equate to an overall point system.
- Assignor Review will be 40%
  - Must work 25 games or more.
  - Accept assignments above and beyond.
  - Accept assignments to all school, not blocked.
  - Number of turn back games when assigned but not accepted.
  - Number of turn back games when assigned and accepted.
    - 1 point 1 to 5 games
    - 2 points 6 to 10 games
  - Number of schools blocked not associated with a personal conflict.
  - Evaluation by Assignor or designated person by the Assignor.
- Any questions about Rating System, Schedule or any other concern contact Perry.
- Not available for a game on a certain day due to time. Do not just decline the game, contact Perry as he may have a later game time for you. Declining a game declines you the whole day.
